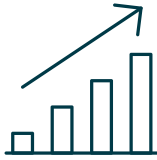
ABOUT QUILTER CHEVIOT

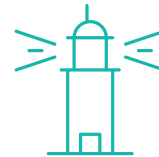

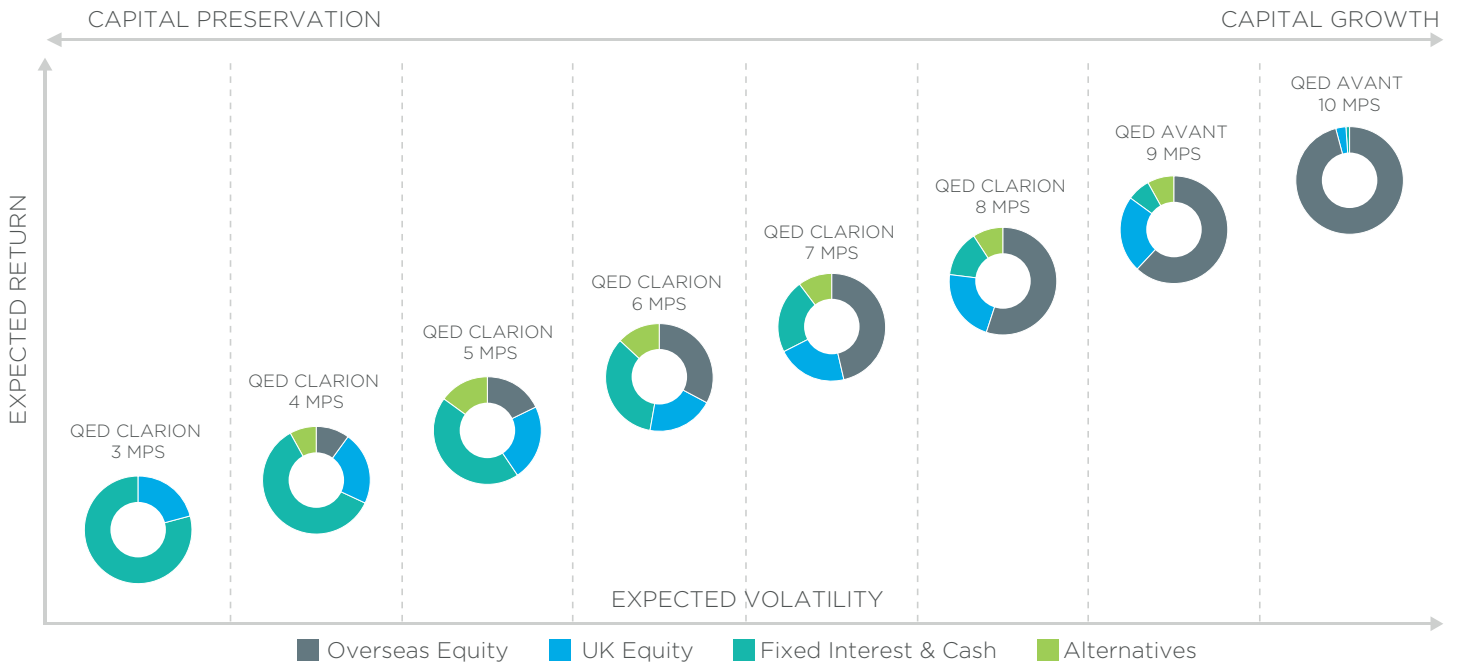
